 SUBJECT: **November 2013 Sales Tax Distribution (September 2013 Activity)**

November sales tax receipts (for September 2013 activity) were \$1.8 million which is \$94k (6%) over November 2012 and \$181k (10.6%) over the November budget. **Year to date we are \$1.8 million (10.6%) over 2012 and \$1.7 million (9.9%) over budget.** We are projecting to be \$1.7 million (9%) over 2013 *and* annual budget at year end.

The year-over-year change includes major construction projects underway in 2013 as well as a large audit adjustment within our manufacturing sector in 2012 (a reduction). These items, in combination, significantly skew the comparison.

Excluding these one-time items, 2013 is \$1 million (6%) over 2012 and \$1 million (6%) over budget.

Key Variances:

- The **Construction** sector contributes to more than half of our year over year gain. There are several major projects underway in both Building Construction (90% over 2012) and Heavy and Civil projects (103% over 2012). The one-time impact of these projects is roughly \$642k. *Excluding* these projects, **this sector is \$271k (17%) over 2012.**
- The **Manufacturing** sector was adjusted by an audit reduction in 2012 which, again, skews the year over year comparison. If we eliminate this adjustment, **this sector is \$70k (6%) above 2012.** *Excluding* the audit adjustment, the transportation category of this sector is up by \$141k (24%) while the remainder of this sector is \$72k (14%) *below* 2012.
